Welcome to SpotAngels!

Sweetch, Inc. ("SpotAngels," "we," "us," "our") provides its mobile applications and related services (collectively, such services, including any new features and applications, and the website located at www.spotangels.com, the "Service(s)"), subject to the following Terms of Service (as amended from time to time, the "Terms of Service"). We reserve the right, at our sole discretion, to change or modify portions of these Terms of Service at any time. If we do this, we will post the changes on this page and will indicate at the top of this page the date these terms were last revised. We will also notify you, either through the Services user interface, in an email notification or through other reasonable means. Any such changes will become effective no earlier than fourteen (14) days after they are posted, except that changes addressing new functions of the Services or changes made for legal reasons will be effective immediately. Your continued use of the Service after the date any such changes become effective constitutes your acceptance of the new Terms of Service.

In addition, when using certain services, you will be subject to any additional terms applicable to such services that may be posted on the Service from time to time, including, without limitation, the Privacy Policy located below. All such terms are hereby incorporated by reference into these Terms of Service.

Access and Use of the Service

Services Description: The Service is designed to help users find parking and avoid parking tickets by displaying the location of parking spots and real-time parking restrictions.

Your Registration Obligations: You must register with SpotAngels in order to access and use certain features of the Service. If you choose to register for the Service, you agree to provide and maintain true, accurate, current and complete information about yourself as prompted by the Service's registration form. Registration data and certain other information about you are governed by our Privacy Policy. If you are under 13 years of age, you are not authorized to use the Service, with or without registering. In addition, if you are under 18 years old, you may use the Service, with or without registering, only with the approval of your parent or guardian.

Member Account, Password and Security: You are responsible for maintaining the confidentiality of your password and account, if any, and are fully responsible for any and all activities that occur under your password or account. You agree to immediately notify SpotAngels of any unauthorized use of your password or account or any other breach of security. SpotAngels will not be liable for any loss or damage arising from your failure to comply with this Section.

Modifications to Service: SpotAngels reserves the right to modify or discontinue, temporarily or permanently, the Service (or any part thereof) with or without notice. You agree that SpotAngels will not be liable to you or to any third party for any modification, suspension or discontinuance of the Service.

General Practices Regarding Use and Storage: You acknowledge that SpotAngels may establish general practices and limits concerning use of the Service, including without limitation the maximum period of time that data or other content will be retained by the Service and the maximum storage space that will be allotted on SpotAngels's servers on your behalf. You agree that SpotAngels has no responsibility or liability for the deletion or failure to store any data or other content maintained or uploaded by the Service. You acknowledge that SpotAngels reserves the right to terminate accounts that are inactive for an extended period of time. You further acknowledge that SpotAngels reserves the right to change these general practices and limits at any time, in its sole discretion, with or without notice.

Conditions of Use

SpotAngels Platform: SpotAngels offers a service that displays the location of parking spots, real-time parking restrictions and enables to alert users of upcoming parking restrictions to avoid them parking tickets and violations. SpotAngels does not provide parking spaces to its users. Moreover, while SpotAngels’ goal is to provide and maintain the highest quality parking information, SpotAngels does not guarantee that users won’t be subject to a parking ticket or violation by parking in a given location. It is the user’s responsibility to check the accuracy of the parking information communicated by SpotAngels by analyzing the current street situation (whether parking signs, colored curbs, temporary signage or other). SpotAngels will have no liability for any parking tickets or violations received by users.

User Conduct: You are solely responsible for all text, information, data, graphics, messages or other materials (“content”) that you upload, post, publish or display (hereinafter, “provide”) or email or otherwise use via the Service. The following are examples of the kind of content and/or use that is illegal or prohibited by SpotAngels. SpotAngels reserves the right to investigate and take appropriate legal action against anyone who, in SpotAngels’s sole discretion, violates this provision, including without limitation, removing the offending content from the Service, suspending or terminating the account of such violators and reporting you to the law enforcement authorities. You agree to not use the Service to:

- b) interfere with or disrupt the Service or servers or networks connected to the Service, or disobey any requirements, procedures, policies or regulations of networks connected to the Service; or
- c) violate any applicable local, state, national or international law, or any regulations having the force of law;
- d) impersonate any person or entity, or falsely state or otherwise misrepresent your affiliation with a person or entity;
- e) solicit personal information from anyone under the age of 18;

Your continued use of the Service after the price change becomes effective constitutes your agreement to pay the changed amount. Arbitration

At SpotAngels's or your election, all disputes, claims, or controversies arising out of or relating to the Terms of Service or the Service that are not resolved by mutual agreement may be resolved by binding arbitration to be conducted before JAMS, or its successor. Unless otherwise agreed by the parties, arbitration will be held in San Francisco, California before a single arbitrator mutually agreed upon by the parties, or if the parties cannot mutually agree, a single arbitrator appointed by JAMS, and will be conducted in accordance with the rules and regulations promulgated by JAMS unless specifically modified in the Terms of Service. The arbitration must commence within forty-five (45) days of the date on which a written demand for arbitration is filed by either party. The arbitrator's decision and award will be made and delivered within sixty (60) days of the conclusion of the arbitration and within six (6) months of the selection of the arbitrator. The arbitrator will not have the power to award damages in excess of the limitation on actual compensatory, direct damages set forth in the Terms of Service and may not multiply actual damages or award punitive damages or any other damages that are specifically excluded under the Terms of Service, and each party hereby irrevocably waives any claim to such damages. The arbitrator may, in his or her discretion, assess costs and expenses (including the reasonable legal fees and expenses of the prevailing part) against any party to a proceeding. Any party refusing to comply with an order of the arbitrators will be liable for costs and expenses, including attorneys' fees, incurred by the other party in enforcing the award. Notwithstanding the foregoing, in the case of temporary or preliminary injunctive relief, any party may proceed in court without prior arbitration for the purpose of avoiding immediate and irreparable harm. The provisions of this arbitration section will be enforceable in any court of competent jurisdiction.

Termination
